#### **Course Description**

A survey of models of the reading process, research on oral and written language development, and significant approaches to reading instruction. Provides instruction for fundamental understanding of the theoretical rationale of the reading and related language arts processes. Note: Course is not appropriate for certified teachers and does not count toward the MAE in Literacy Education.

#### **Course Objectives**

1. Students will examine the various models of the reading process for adults learners.
2. Students will analyze and explore current topics in adult literacy acquisition.
3. Students will create a project demonstrating preliminary awareness and understanding of the theoretical rationale of the reading and related language arts processes.

#### **Texts:**

There will be significant reading in this course, including several books. Your professor will provide you with the texts you need. You will not need to purchase any yourself, but books will be provided in class and reading materials will be shared with you through Blackboard.
